#### **DUTIES AND RESPONSIBILITIES**

- 1) It shall be the duty of the Anti-Ragging Committee to ensure compliance with the provisions of these Regulations as well as the provisions of any law for the time being in force concerning ragging; and also to monitor and oversee the performance of the Anti-Ragging Squad in prevention of ragging in the institution.
- 2) To take appropriate action in case an incident of ragging is reported by Anti-Ragging Squad of the institute and to further conduct enquiry and submit report along with punishment recommended for the offenders;
- 3) To uphold and comply with the directions of the Hon'ble Supreme Court and be vigilant on any acts amounting to ragging;
- 4) To publicize to all students and prevalent directives and the actions that can be taken against those indulging in ragging;
- 5) To consider the complaints received from the students and conduct enquiry and submit report to the Anti- Ragging Committee along with punishment recommended for the offenders;
- 6) Oversee the procedure of obtaining undertaking from the students in accordance with the provisions;
- 7) Conduct workshops against ragging menace and orient the students;
- 8) To provide students the information pertaining to contact address and telephone numbers of the person(s) identified to receive complaints/distress calls;
- 9) To offer services of counseling and create awareness to the students;
- 10) To take all necessary measures for prevention of Ragging inside the Campus/ Hostels.
